# From the Board...

Notice to members of bylaw updates. Section 17 - Officers, added **GM** in admin spot. Section 18 - **All committees may consist of more than one board member.**

## **I. Property of Greensburg Country Club**

Property owned by the Greensburg Country Club may be sold. A majority vote of the board of directors is required to sell the item(s). A notification describing the item(s) will be posted on the bulletin board in the club lobby. It will be posted for 2 weeks (14 days). The posting will allow for members to express their interest in bidding on the item(s). Offers may be solicited from non-members as well to ensure the club gets the best price. The final offer will be presented to the board for approval.

## **II. Equipment & Irrigation Fund Protection**

A separate account will be used to hold funds specifically for the purchase of course and irrigation maintenance. The initial source of funding is the line item on member invoices designated as "equipment fund." Other funding may be obtained from donations. To insure protection of this account the board must have a majority vote to release funds explicitly defined as that equipment which performs a purpose for course and/or irrigation maintenance.

**A motion was made, seconded, and passed to move on to the next phase of approving the changes/additions to the bylaws. Next board meeting will be July 12th at 5:30. If any member wants to express their opinion on these changes they need to notify Kurt so he can note your plan to attend.**
